Once your loved ones have been provided for, leaving a bequest in your will is one of the most generous gifts you can make.

Most of us want to make the world a better place, particularly for those who will inherit a society they did not create. Sometimes working out how to make that difference seems too overwhelming to contemplate, but leaving a bequest in a will is an easy way for some of us to help future New Zealanders.

By choosing to leave a bequest to Aviva, you are choosing to leave a legacy of support for a violence-free Aotearoa.

Types of Bequests

- **Residual Bequest** - the remainder of your estate after other bequests have been paid. Many find this the simplest way to support us after provisions have been made to their loved ones.
- **General Bequest** - a fixed sum of money or percentage of the total value of your estate. Solicitors advise you review fixed sums regularly to account for inflation.
- **Specific Bequest** - a gift of a particular piece of property (e.g. house, furniture, jewellery). We recommend contacting us ahead of making this type of bequest, to discuss how such a gift may be utilised or transferred.
